



Our responsibility is to review the annual return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report (NY0593)

On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

We note that the internal auditor has ticked "No" in Box F on page 5 "Petty cash payments were properly supported by receipts, all petty cash expenditure was approved and VAT appropriately accounted for".

As we have seen no evidence that the Council maintains a petty cash float it may be this is an error and that the answer "Not covered" with an explanation should have been ticked. If, however, the report by the internal auditor is highlighting an issue, the Council should take steps to improve its controls in this area as a matter of urgency.
